# Officer reports:

- President report From the mayor's meeting: 1. The city has applied for a grant addressing city blight. (Neighborhood stabilization initiative) There is a good chance we will get it. The city will target areas around schools first. 2. Parks millage. We need to petition our county commissioners to use some of the money for our park and the river trail. Matthias suggested a boilerplate letter that anyone could use. 3. The State is reviewing guidelines about marijuana. The police are awaiting these guidelines. 4. There will be more strict enforcement of snow ordinances. A tag will be put on homes and if the snow is not removed, a fee/lien will be placed on a person's property tax. Seniors and the disabled will not be tagged. Winter street parking was discussed. It was suggested that we invite Jessica Yorko and Jody Washington (ward reps) to our next meeting.
- <u>Vice president report</u> Internet hosting will be discussed at the officer's meeting next Monday.
- <u>Treasurer report</u> David does not think he has tax papers relative to the old 501c3. Dorothy thinks that it was not MPNO that had a 501c3, but a separate group that was formed in the neighborhood to address the problem of foreclosures.

- Park and Pool Natalie and Ellen attended the November Parks board meeting. The city plans to open the pool next summer. It has had needed –immediate- repairs, but its condition was termed "dire". We will need to advertise and promote the pool. The city Parks board is looking for a rep from the 4<sup>th</sup> ward. Natalie asked the board for attention to erosion, fishing areas, hardscapes/historic structures, and the parking lot on the SW corner. The board agreed to send the park's landscape architect to meet with us and devise a plan. Could we tie into REO town revitalization? GM has "factory town" grants.
